Updates and progress in the fight to stop and/or suppress invasive species in the Upper Columbia. This includes actions to suppress northern pike; eDNA testing to support early downstream detection; results of a rapid response exercise to simulate actions if zebra and quagga mussels are detected, and the emergence of flowering rush in the system.

The Columbia Basin Project (CBP) supplies irrigation water to over 670,000 acres, making it the largest water reclamation project in the United States. Fed by Columbia River withdrawal from Lake Roosevelt, this session focuses on the status of making surface water available to farmers now relying on unsustainable groundwater supplies in the Odessa Subarea; results from a fall survey of diverse CBP stakeholders to identify future priorities; development of a Columbia Basin Sustainable Water Coalition; and perspectives from the Washington Potato Commission, an association representing farmers that produce annually over 10 billion pounds of potatoes in the CBP.
